Part 1: Specific Terms and Conditions

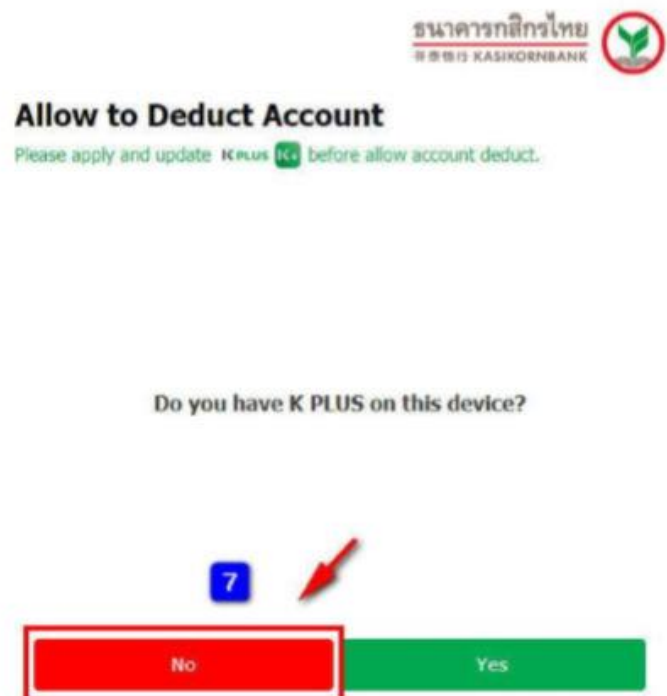
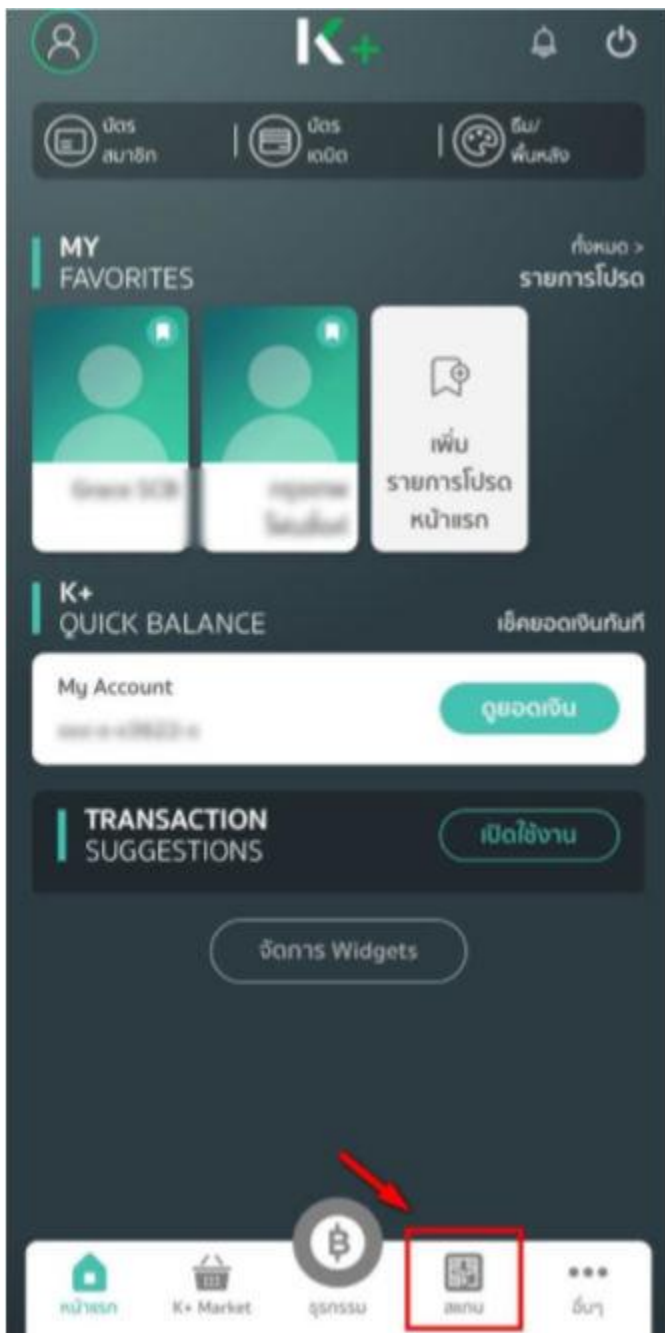

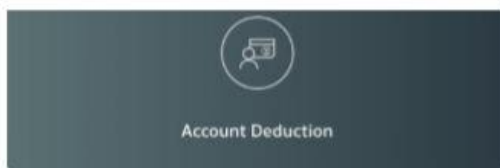
